#### **Use instructions**

#### Dosage:

When using with Divermite Room Care dosing unit, fill keyed Room Care R5.1-plus 300ml application bottle with water to fill line. Push the Divermite dispenser twice to dispense 30mls of product. Securely screw on the trigger head. Ensure the nozzle is closed and gently shake the bottle to mix the product.

When using with a DQFM dilution dispenser unit, fill the Room Care R5.1-plus keyed spray bottle (300ml or 750ml) to the fill level mark directly from the DQFM dispenser. Securely screw-on the spray trigger.

## **Application**

Spray upwards into the centre of the room and spray onto curtains and fabric furnishings if required.

NB: Between refills, rinse out bottle with clean water.

## **Product compatibility**

Do not spray over or onto plastic surfaces. Do not mix with other cleaning products. Do not use with other dilution systems or methods. Do not use undiluted.
